# Hints, Tips, and Innovations

Share your expertise with other members

This month I've got two tips. First, add a little whimsy in your layout. If you've been to Highwheeler you may have seen some, and if you go to Trainfest, take a few extra minutes and see if you can notice some instances of whimsy in the layouts on display. The motivation is pretty obvious: If you notice something unexpected on a layout, you're apt to spend some time looking for other unexpected items, and probably see some details you would have otherwise

overlooked. It's all designed so as not to take the layout for granted. Take the Museum of Science and Industry's layout, for example. There is so much to see, literally from Chicago to Seattle, that some of the details get overlooked, especially those in the wooded areas, and especially if you've seen the layout a few times. Then, either you notice, or someone tells you about, the campsite that is being raided by bears. Once you notice that, all of a sudden, it's like looking at a brand-new layout. You notice the path of the stream, the rock placement; in short, you look at every detail with fresh eyes. And isn't that what the builder wanted?

So, how do you create whimsy? There's always the nude sunbather at the beach, or the dinosaur in the forest, but you can also make more subtle changes to your layout, like giving one of your businesses a tongue-in-cheek name. I plan to place protesters around some of my downtown businesses, like people claiming, "Morton Salt is unfair to umbrellas," in hopes that the viewer will then notice some of the building details I worked so hard to add.

My second tip is: attend your local division NMRA meeting. Reasons for joining the NMRA are pretty basic. According the NMRA website (<a href="https://www.nmra.org">www.nmra.org</a>):
