Mid West Region NMRA – Spring 2022

President's Report Bob McGeever President, MWR

I have a few topics to cover this month. The first topic: Email Communications with the Membership.

There is a developing school of thought that tools and services needed by all the divisions could be provided by the Regions or the National. The Divisions would not have to spend their time and resources "reinventing the wheel". Reliable email communications with the membership is one of those tools. These days, it is fundamental to running a division.

My home division converted the monthly newsletter from a paper copy mailed to each division member to a digital newsletter distributed to the membership using email. We did it because the cost of the hard copy was unsustainable. The hard copy format was fixed at twelve black and white pages per month. The digital version broke those restrictions. We could have 20 color pages if we had the content. Or just 8 color pages if it was a slow month. All in all, it would be a big improvement at a much lower cost.

Everything was moving along nicely until we tested the email distribution. Some members got the notice, some did not. Our editor was using a personal email account to send out the notice. Some ISPs were okay with the large number of folks on the email, some were not. And we don't even want to talk about the work needed to maintain the mailing list in her private email account. It was a mess. Instead of making it simple to distribute the newsletter, we had made it way more complicated for our editor.

Back when I was the MWR Secretary, I would have similar problems with the meeting notices and meeting packets I sent BOD members. A large number of folks copied on an email with several large attachments just plain freaked out some of the ISPs some of the time. There was no consistent pattern to the failed emails. Many times, I did not even get a rejection notice from the ISP.

The MWR has had a Constant Contact email service account for several years. It was originally used by the Region and the Fox Valley Division. They split the cost. The Constant Contact service is recognized by the ISPs as a safe bulk email service. All of

the regional members and division members are organized into mailing lists built from the monthly membership reports we get from the National. There is also a mailing list for the MWR BOD members and Division supers. Jim Osborn suggested we should use Constant Contact to handle the BOD meeting communications. I had to admit I had no idea why I wasn't using it other than my predecessor wasn't using it when I took over the job. It is what I call a "duh" moment. Once we converted to Constant Contact for BOD communications, things started to run really smooth. You may know where this story is going.

My home division started to use the Constant Contact service to distribute the newsletter. Then we started using it for meeting notices, Zoom links, and other communications to the division members. It worked really smooth. We split the cost with the Region and the FVD.

When the WISE division started it's rebuild, an early issue was reliable communications with the members. They started using the Constant Contact service to communicate to the division members. It worked really smooth. Now we were splitting the cost four ways.

I had another "duh" moment. Instead of just a few divisions using this service, and sharing the cost, why not roll it out to all the divisions and the region will pick up the tab for everybody. It would cost the region about \$600 a year to provide this tool to all the divisions. The MWR BOD approved this idea at the May meeting. Currently five of the MWR divisions are using the service. The others will be phased in as the interest develops. Contact Jim Osborn at: webmaster@mwr-nmra.org if you would like to join the program. He will fill you in on the process.

One of the lessons to be learned from this is: You are not alone. Whatever issue you are trying to address for your division, you are probably not the only one with the same challenge. Talk to your counterparts in other divisions. See what they have done when faced with the same issue. One of them may found a good solution you can copy.

Another lesson to be learned from this: If all the divisions in the region have the same issue to solve, we really should be looking for a regional solution. I was thinking the next regional solution might be a Zoom account. We all use them. Some accounts are paid for by the division and some by a division member. But Zoom is a little more

complicated. And the upcoming release of the "NMRA Interchange" may provide the functionality of a Zoom meeting at no cost to a division. So that is on hold for now until we know just what the NMRA Interchange will do for us.

The second topic: The fall meeting of the MWR BOD.

My recollection is that for the past few years we have held the fall meeting of the BOD on a Sunday in November somewhere close to the Wisconsin – Illinois state line. While this is really convenient for me, it is not a location near the center of the division. So, I sent an email to selected Division Supers looking for a location for the fall BOD meeting. Jim Tatum of the IVD was the first to respond so he gets the honor of hosting the fall MWR BOD meeting in October, possibly on a Saturday, in Peoria Illinois. We have some details to work out. We will keep you posted.

The third topic: No Regional Convention in 2023.

To be blunt, we don't think we have the horsepower and the lead time to put on a convention in 2023. Especially with the COVID induced loss of active members. The success of the Indy Junction convention demonstrated that, in this day and age, it takes more than a single division to put on a worthwhile convention. We need to figure out a way to put on the convention that aligns with the resources we have available for the work. Maybe it should always be a multi-division or multi-region event? Maybe we should put on a medium to large convention every two years instead of a small convention every year? Indy Junction drew over 500 attendees. A typical regional convention draws maybe a third of that. The larger the attendance the more we can budget for the convention content. Steve Studley and Dan Hinel are the leaders of the Convention Committee, and they are exploring these topics. We are planning to hold a convention in 2024.

Some help maybe coming from the National. They are looking into a national contract with a ticketing service. Details are still preliminary but having an established method to collect the fees and publish schedules for a convention would be a big help. One less wheel to reinvent.




